RESCUE CHALLENGE RULES

1. All teams must be registered for the convention.
 2. Unregistered competitors will result in disqualification.
 3. Participants must wear long pants or coveralls, sturdy shoes (no flip flops), leather gloves, helmet and safety glasses.
 4. A team may consist of up to five members, including a working captain.
 5. The captain must maintain control.
 6. Judges have absolute control of each challenge.
 7. Time will be stopped for any safety hazards but you will be penalized.
 8. Order for the challenge will be drawn for by the captains.
 9. First thru third place trophies will be awarded.
 10. Unsportsmanlike conduct from any team members before, during, or after can result in immediate disqualification.
 11. Preregistration is a must.
 12. **THE DECISION OF THE JUDGES WILL BE FINAL.**

RAMBLING RESCUE RACE CONTEST RULES

1. Participation must be registered at convention.
 2. **PARTICIPANTS WILL BE DRESSED IN FULL PERSONAL PROTECTIVE GEAR.**
 3.
 - A. Maximum cart length
 - B. Maximum 30" width (not including wheels)
 - C. 18" Wheel maximum diameter
 - D. 300# maximum cart weight (not including occupants)
 - E. No mechanical propulsion devices
 - F. One driver per cart
 - G. One pusher per cart
 4. Order of finish determined by order of crossing finish line with 1st, 2nd, and 3rd place awarded on final race.
 5. No appeals for collision, interferences, etc. will be allowed
 6. This is designed to be a fun contest; contestants must keep that in mind.
 7. Squads may have more than one cart entered but each cart must have its own separate driver and pusher. (No one cart may be entered more than once).
 8. Each squad at the convention will be given one ballot to cast their vote on appearance; 1st, 2nd, and 3rd places will be decided by popular votes received.
 9. If the number of entries exceeds a safe number for one race; separate heats will be conducted with heat winners being allowed to compete in the final race or subsequent heats for final race.

2. Unregistered competitors will result in disqualification.
3. A team may consist of up to five members.
4. The captain must maintain control.
5. **THE JUDGES HAVE ABSOLUTE CONTROL OF THE "PITS".**
6. No times will be assessed for a "FREEZE".
7. The times will be stopped at 20 minutes.
8. The tools for the competition will be furnished. However, if you elect to use your own tools, please inform us at the captain's meeting.
9. Order of competition will be drawn for by the captains.
10. Team must have submitted entry form by October 15th.
11. First thru third place trophies will be awarded.
12. Unsportsmanlike conduct from any team members before, during or after can result in immediate disqualification.
13. You will be judged on safety, anything that can be hazardous you will be stopped.
14. You will also be judged on coordination and team work.
15. Communication between incident commander and the team.
16. Patient care such as maintaining C-Spine and maintaining safety of the patient or patients.
17. **THE DECISION OF THE JUDGES WILL BE FINAL.**

TOP MEDIC AWARD RULES

The new top medic challenge rules are simple, how good a medic are you per Alabama Standards. You will have an assistant provided to you that will only perform skills you appoint them to do.

1. You will be tested on your knowledge of Alabama Protocols.
2. You will be tested on your skills.
3. You will have an extended scenario that you will have to work step by step by protocol and by doctor's orders.
4. This challenge will have a time limit of 30 minutes, if there is a tie on points gathered, it will come down to time.

MAKE SURE YOU VERBALIZE ALL ACTIONS AND PROCEDURES PERFORMED. THIS WILL NOT BE AN EASY CHALLENGE, BUT WILL SHOW THAT THE AARS HAS THE BEST OF THE BEST. YOU MUST PRE REGISTER FOR THIS CHALLENGE. THE TOP MEDIC ONLY HAS ONE TROPHY, ARE YOU UP FOR THE CHALLENGE, BUT THERE WILL BE A PRIZE WORTH YOUR TIME.

FIRST AID CONTEST RULES AND EQUIPMENT LIST

EACH TEAM WILL CONSIST OF FOUR MEMBERS INCLUDING A WORKING CAPTAIN. A ROSTER OF TEAM MEMBERS MUST BE SUBMITTED.

1. A written test for all team members.
2. One rescuer CPR – Only one person from each team to compete, selected by the team captain.
3. A practical test consisting of multiple trauma victims, to include initial patient survey, vital signs, and treatment.

Each team is to furnish its own equipment and supplies. Judges will be selected from AARS membership. Team scores will consist of total scores for all three parts. The sequence in which teams compete will be determined by a drawing at the team meeting. Trophies will be awarded for first, second, and third place.

SCRAPBOOK CONTEST RULES

Entry rules

*Scrapbooks must be no bigger than 20" x 20" and must be bound. Pages stapled together do not constitute being bound.

*Scrapbooks with pictures of victims will not be allowed entry into the Scrapbook Contest.

Scrapbooks will be judged based on the following:

*Squad name should be on front cover.

*Material in scrapbook should date from conference to conference.

*Material should pertain to the squad and/or squad members involved in squad activities.

*Color scheme

*Arrangement & neatness

*Originality

*Labeling (handwritten or typed explanation of all pages, photos & newspaper articles)

The decision of the Judges will be final.

Awards

Wendell Price Award

The Wendell Price Award for Outstanding Community Service is presented to a squad member who serves his squad and community on a regular basis. This award is for someone who contributes their time by doing routine activities for their organization or always making themselves available for search and rescue operations. In addition, this person might serve the community in other ways, such as teaching CPR or First Responder courses. This award is not for singular heroic acts. The winner of this award will be presented a plaque at the banquet. Runners-up will be awarded a certificate of recognition. Nominations for this award must be received by the association no later than November 1st' each year.

Rescuer of the Quarter

The Rescuer of the Quarter Award is awarded quarterly for a squad member who performs an outstanding rescue act that deserves recognition. The winner of this award is presented a plaque at the quarterly meeting. Nominations for this award must be received no later than 10 days prior to the Quarterly Meeting.

Citizen of the Year Award

The Citizen of the Year Award is to recognize someone *other than a squad member* who has done some outstanding rescue act since the last convention. The winner of this award will be invited to our banquet and will be presented a plaque. Nominations for this award must be received no later than November 1st each year.

Glenn Parris Award

This award is presented in honor of our founder Glen Parris. The recipient of this award is chosen from the winners of the Rescuer of the Quarter for the current year.



Voice for the Missing


NOTE: The purpose of this column is to provide the missing persons in Alabama with an additional venue to share their stories. We also thought it would be nice for the searchers (You) to get to know your victims a little better. Too often, we leave a search without finding our victim and never hear about the case again. We are all professionals, but we also care and have questions of our own about our victim's. Most of the time this is due to the media's lack of interest in most missing person's cases. I have spoken to many families about sending in a story for our magazine that tells us a little more about our victims than what we read on a missing persons flier. All of these families were more than happy to share their stories with us. Please bear with me as this is the first time I have submitted anything to the magazine. The subject of missing persons, especially searching for the missing, is something that I am very passionate about. Because of that, I always feel like there is something more that I can do. Writing this quarterly article is my attempt at doing a little more.

My story this quarter is about two women that I have gotten to know pretty well. Their names are **Nadia** (Or Nadi as her mother calls her) and **Tabitha** (Everyone just calls her Tabby). I have gotten to know these girls so well that I almost feel like I've known them my whole life. You know how it is when you have a really close friend and you know every detail about them? That's me, I know their favorite T.V. shows, the guys they dated, their favorite foods and music. You know, the typical stuff. Unfortunately, I also know things like, **Nadia** was wearing a green Tria Market shirt when she disappeared and was actually last seen at her apartment. **Tabitha** was wearing a black dress when she disappeared and was last seen standing in a driveway waiting for a ride from the last person to see her alive. That's the worse part about my friendship with these girls...I've met their families and friends, but I never got to meet them. Being friends with a missing person that you've never met can be difficult, but, worth the effort.

These two really are almost complete opposites. Nadia is the shy, soft spoken and sometimes naïve girl. Tabitha is the true southern girl with something to say and the attitude to back it up. Here's a little history on both of them....

Nadia Kersh was born in Russia and after many difficulties found herself in a very crowded, underfunded orphanage. She and her sister were eventually adopted and came to live in the U.S. As you can imagine, living with an American family was like learning to walk all over again. Nadia had problems in her young life like most of us. The adjustment from Russia to the U.S. was difficult and it was harder for her to fit in with other children her age. Eventually, her parents found a school that Nadia loved. There she met several girls that she would remain friends with until this day. She learned how to be herself and live. And that's what she did. She eventually moved to Alabama a few years after leaving her school and began a new life on her own.

Despite what has been said in the news, Nadia and her twin were not reunited in Birmingham. Nadia and her sister were in contact with each other throughout their lives. They always knew where to find each other and Nadia finally came to Birmingham to live with her sister for a brief period. After her sister married and moved out of state, Nadia was on her own for the first time in her life. Considering her difficulties adjusting during her childhood, Nadia was doing very well for herself. She had a job, friends and eventually a baby. Unfortunately, being naïve as I mentioned before, Nadia also allowed an unknown danger to enter her life. Don't get me wrong, I'm not being mean when I say she was naïve. Nadia was a girl that only sees the good in everyone. She made bad decisions when choosing friends because she did not understand what people are capable of. In her mind, no one would ever have any reason to hurt her. In all honesty, I still don't understand why someone would want to hurt her. The man suspected of murdering her has been arrested now and there are still no answers to that question.



Tabitha Franklin, as I said before, is a southern girl born and bred. Tabitha had no problems blending in with her peers. As we all know, that's not always a good thing. Tabitha was a beautiful girl and, I would imagine, could have anything she wanted. What she wanted was to live her life to the fullest. She wanted to love and be loved...she did and she was. Maybe Tabitha grew up too fast. It happens to a lot of girls these days. By the time she became an adult, she was on a road that she never intended to take. How'd she wind up there? Love, of course. She tried many times to get out of a bad situation and always found herself right back in it.

By this time, Tabitha had 3 beautiful children that she loved something fierce. However, she also had 3 children that needed her and sometimes she felt like she would never live up to their expectations. How could she when her own life was so out of control? She did it by loving them. She loved them and they knew it. Sometimes Tabitha would be gone for a few days for no reason. It didn't matter though, her children always knew she was coming back. She would never leave them....she loved them. And then one day she didn't return. Remember that road I mentioned? She never got off of it. She tried and tried, but, he was always there. The one time Tabitha tried to end the bad relationship she was in, her children were threatened. Throughout the duration of this relationship, Tabitha made other bad decisions, drinking among others. Not uncommon for a woman surrounded by violence and feeling like she is in an unending cycle. Unlike Nadia, Tabitha knew what people were capable of....after all, she had already seen this dark side. Even so, like so many others, she never expected this. She never expected her face to become one of so many missing persons.

So, these two ladies have “Almost” nothing in common. Almost....Here’s what they do have in common: They both loved their children dearly and would never....NEVER leave them willingly. They were both young and beautiful with their lives ahead of them. They both have families that love them and will stop at nothing to get the answers they need and deserve. They are both missing and need to be found. AND, most importantly, they both have us looking for them. Not just “Us” with Walker County Rescue, all of us in the AARS. Some of you guys have already received a call or 2 or 3 from us to assist with the search for Nadia or Tabitha. If you have not, you probably will.

One important thing that we have learned since we began working with families and law enforcement on missing person’s cases is this: Just because the media may have lost interest in a case, that does not mean that it has been forgotten. The law enforcement agencies working these cases are doing just that....working them. They never forget. Just because you don’t read about a search in the newspaper, that does not mean a search is not being conducted. Just because law enforcement has not announced a suspect’s name on the news, that does not mean that they are not keeping tabs on someone and getting closer and closer to an arrest. Working closely with law enforcement has become a big part of what our team does now. We have been fortunate enough to see all the hard work they have put into these cases. As for the families, they are also working these cases. After all, when their loved one disappeared, they inherited a new job. They just became the official spokesperson for their family member. Believe it or not, their job is much harder than ours.

In closing: I plan on submitting a story on at least 1 missing person every quarter. I figure that even if I submit 2 at a time, I will never run out of missing persons in Alabama to write about. The unfortunate truth is that even when a victim is found, another takes their place. My hope is that everyone gets something from reading this. Keep reading, at some point and time I will write about someone in your area.

Finding a Unclothed Man

It was mentioned at the last quarterly meeting to ask me about finding a naked man so I decided to share the story with you all. SARTEC K-9 unit was called to St. Clair County a few years back to help in locating the body of a man who had been missing for six days in the 100 degree heat. Searchers had searched the area with no signs of the man. This was to be the last day of the search. If the dogs did not turn up anything they were going to discontinue the search. SARTEC arrived early in the morning with several dogs. The dog teams were sent out to cover different areas of the hilly wooded area. Searching for a couple hours, teams came in for a break and refreshments. Afterward recoup Team Lady was asked to check out an area where a shoe had been found the night before. Searching the right side of road near a pond no indications were given. Moving across the road to a wooded area, Team Lady entered the woods finding a sock. As they went into the woods they continued on to a running creek. The handler noticed a footprint in the mud and pointed it out to the searcher with her. Handler gave Lady the cadaver command. Going to water Lady sniffed came back to the handler and gave a live alert at which time the handler told her to go find. Several times working thru the briars following the creek, Lady gave a live alert, at one point getting out of handlers sight. Calling for her, the handler and searcher heard a weak voice calling for help. The searcher with the team yelled and asked if he was the person they were looking for to which he replied yes and that he needed help. Working their way to him the handler realized, about 500 feet from him, that he had nothing on. Turning around while other searcher went to evaluate him, the handler radioed in that Team Lady had a find and that he was alive. Standing on a stump the handler verbally helped other searchers work their way in to them. With the help of team Lady from the SARTEC K-9 unit a father was reunited with his 3 year old son, dehydrated and cut up from the briar's, but alive. Now you know the rest of the story.

Busy, Busy, Busy

We have been very busy the last few months with searches from Hueytown to Smith Lake to Lamar and Lawrence County it has been non-stop. The only thing I can say is if I ever go fishing I want to go with Haleyville Rescue squad because if there is anything out there, by golly, they are gonna catch it. Of the last few calls that they have responded to help us one victim was recovered at around 100 ft, the other in swift water and both by dragging.

As for dive teams, I cannot say enough about all the divers that have responded to help. We had divers from the Smith Lake Task Force, Hoover PSD team, Haleyville, LASAR and several others that I did not even get to meet or thank. These guys worked in 100 plus feet of water with zero visibility to 20 or 30 feet of water with a very swift current. Either way you go you definitely get a work out, and they performed like pros. I also want to thank LASAR again for an AWESOME PSD class because it continues to make diving easier and more productive. You take the basics and continue to build on them and you always remember what you learned in the class.

I do need to give kudos to Dusty, he is now 6 out of 6 on the water and thanks to all of the people that have helped us throughout the years in training Dusty. I need to thank Darcy and the crew at NASDA for help on some very sensitive searches and Chip and crew from HEMSI for their help in Town Creek and also on some discreet searches. Thanks to SARTEC K-9 for being on the way to help when we found the victim on Smith Lake.

I will say that even though one area was checked by a diver and another K-9 team (not an AARS member) and Texas Equusearch was called in, I will still listen to what Andy told me.....Trust your dog, trust your dog, *trust* your dog. And if you don't trust your dog....TRUST YOUR DOG! Why? Because two days later they drained the lake and guess what they found? Yep, the victim, about 20 feet from where Dusty alerted. On this particular search Dusty jumped in the water. He normally doesn't get in the water, as you can ask some of the guys from the Lamar County search who had to tempt him with pretzels to get him in the water. I was not able to go the first day since I was at the fire department so Angie had to take Dusty. They took Dusty out on the boat after he jumped in the water and after having found some shoe prints at the edge and he alerted again on the boat. So, all along we knew something was there.

The search in Lamar County was an excellent example of many squads coming together to work as one for a common goal. We continue to work missing persons cases and have spent countless hours on searches but thanks to some dedicated members we press on and continue to "fight the good fight".

We were fortunate enough to be a part of the first Basic SAR class which was held in Addison and had a very good turn-out. I hope that everyone had fun and learned something. We are holding another class in July and Haleyville has been gracious enough to host it. We plan to have at least one more, probably hosted by Coosa Valley before the conference and to have an advanced class at the conference in November.
